Lisa,

Speaking as a member of the propane industry, I'd like to request that the compliance date of January 1, 2023 as specified in 2.21.2(b) under MOS-20.5, which is under consideration by the Laws and Regulations Committee, be changed to January 1, 2025.

My reason for this request is that if this provision is accepted for publication at the upcoming meeting in July, there will be insufficient time to disseminate the information to those in the propane industry that are affected by the change and procure the necessary equipment. I also would point out that when this provision was first being drafted (2019, I believe) the January 1, 2023 date was proposed. Now, two years later, it only seems appropriate that the compliance deadline be extended to allow the propane industry adequate time to comply.

Please let me know if this email can be distributed to the Laws and Regulations Committee, or if I need to send it specifically to certain individuals.
